



1. RULES & WAIVER OF LIABILITY

Contest is open to all Australian residents aged 18 years or older. Persons aged under 18 but over 16 may compete with the permission and signature of a legal guardian. This guardian must be present on the day of competition. Employees of Harrys Schnitzel Joint are not eligible to enter.

2. TO ENTER:

CAREFULLY READ THESE OFFICIAL CONTEST RULES AND ENTRY FORM FOR THE HARRYS SCHNITZEL JOINT EATING CHALLENGE INCLUDING THE ELIGIBILITY REQUIREMENTS AND WAIVER OF LIABILITY PROVISIONS. Complete and sign this document below. All entry forms and photos from the challenge become the property of Harrys Schnitzel Joint.

3. CONTEST RULES:

There will be one preliminary round of competition held at each store. A deposit of \$25 must be submitted in order to register and will be refunded on the day of competition, providing the contestant is present and participates. The final round will be held at the Jesmond on Thursday night September 9th. Each competition will run for 15 minutes, as each contestant attempts to eat three Famous schnitzel wraps during this time frame. The winner is judged by the amount of complete Famous wraps consumed in the fastest time. Winners will be decided by Harrys Schnitzel Joint staff. Harrys Schnitzel Joint reserves the right to disqualify any contestant it deems unfit to participate without explanation. Their decision is final and will not be negotiated.

Contestants may eat either sitting or standing in their pre-designated area using their hands only. A contestant must completely eat one Famous wrap before proceeding to the next. Contestants must eat each Famous wrap whole without pulling it apart. A contestant must wait for the starting signal to begin eating and may not touch any Famous wraps prior to the starting signal. A contestant must stop eating and must promptly place their hands down on the table or at their side at the 15 minute mark deemed by the stop watch. A contestant may not put any additional food in their mouth after the ending signal, but will be allowed 5 seconds to swallow any food already in their mouth. If a contestant regurgitates, he or she will be disqualified. Judges will be on hand to assure adherence to contest rules and to disqualify a contestant who fails to adhere to the rules. Grounds for disqualification include:

- False or incomplete entry form or liability waiver
- Any health risks that could jeopardize the contestant's health or well being
- Under the influence of any substance
- Appearance is deemed inappropriate by Harrys Schnitzel Joint staff
- Starting prior to the start signal
- Continuing to eat after the ending signal
- Failure to completely eat a Famous wrap before beginning to eat another Famous wrap
- Regurgitating

Winners will be determined by:

- Eating all three Famous wraps in the fastest time in the allotted 15 minute timeframe OR
- Eating the most complete Famous wraps in the allotted 15 minute timeframe
- Winners from the Preliminary Round will be awarded a spot to compete at the Jesmond store for the title of Schnitzel King and its relevant prizes.



4. PRIZE AWARDS- FINAL ROUND:

Final Round prizes will be awarded as follows:

- 1 Schnitzel King t shirt
- \$200 Harrys Schnitzel Joint Gift Card
- Bragging rights as the 'Schnitzel King' of Newcastle for 2021

All participants agree to the use of their name, voice, likeness, and city/town/village for advertising or trade purposes and to cooperate reasonably in any effort to promote or publicise Harrys Schnitzel Joint Eating Challenge. Apart from the prizes associated with being selected as a winner, Harrys Schnitzel Joint shall not be obligated to compensate you in any way for such publicity.

5. ACKNOWLEDGMENT OF RISKS AND WAIVER OF LIABILITY:

Contestant certifies that they are in good health and deemed fit by a medical professional to participate in the Harrys Schnitzel Joint Eating Challenge.

Contestant acknowledges that there are risks of personal injury, illness and possible loss of life, and risks of damage to or loss of personal property, which may result from participating in this contest. Contestant voluntarily enters Harrys Schnitzel Joint Eating Challenge and assumes all of these risks.

Contestant, as a condition of entry, agrees to indemnify, defend and hold harmless Harrys Schnitzel Joint and affiliated companies, their vendors, their advertising, promotion and public relations agencies, co-sponsoring companies and their affiliates and agencies, and all officers, directors, employees and agents of the aforesaid entities, from any and all claims and costs, including attorneys' fees, relating to, arising from or in connection with participation in this contest or the receipt or use of any prize. In so doing, contestant releases and indemnifies the aforesaid entities and individuals from liability for injuries or damages of any kind arising from or in connection with participation in this contest or the receipt or use of any prize.
